# PORT LINCOLN GOLF CLUB MANAGEMENT COMMITTEE MINUTES 8-5-17 OF MEETING HELD IN CLUBROOMS AT 7.30pm

**COURSE MATTERS** Course report tabled.

- 1. Extra to last Monday's meeting
  - a. <u>Costs for rainbird system</u> have been firmed up- for everything excluding Rainbird trial gear \$253,800 inc. GST which we can claim back. Andy Blacker will send through so it can be emailed out.
  - b. <u>Staged approach to irrigation set up</u> If we started with 14<sup>th</sup> and 15<sup>th</sup> fairways and connections to everything else other than fairways would only save \$95,000 compared with doing the whole lot at once which would total close to \$540,000.
    - For detailed Key Points re inclusion of full irrigation system please refer to sheet provided by Andy and sent out with these minutes. (I had some down but Andy has all of the points listed).

Before anything can proceed firm quotes and engineers' report are needed. Possible sources of funds include loan from District Council of Lower E.P, Bendigo Bank loan/grant, Debentures (amounts of \$1,000, \$5,000, \$10,000 and \$50,000 were mentioned as possibilities). Secretary to ascertain who set up debentures before. (Since the meeting have found that it was Ray Glendenning when he was treasurer. They were \$1,000 each, 48 were issued in 2004 and issued for periods of 1 to 5 years.).

Moved: K. Mors Seconded: R. Nourse 'The Club now fully implement upgrade of irrigation system as well as new dam for a total cost of \$540,000'. Carried

- 2. <u>Car park lighting</u> To begin with lower the light which is there and put another light on- if that doesn't work look at a further option.
- 3. <u>Pipes removed by bike club</u> Andy Blacker to draft a letter which will be signed by Andrew Pascoe letting firm who upgraded the road know that it will cost about \$1500 to fix up the damage done by them. This would cover the cost of the pipes which had earlier been promised to the Club.
- 4. Mery Howell no longer being able to volunteer Secretary to write a letter of thanks to Mery for all the work he has done over many years. Mery was chain-saw ticketed. There is a course in Adelaide and suggest Nathan Jones gain chain saw ticket. Complete Personnel will be approached re funding for this.
- 5. <u>Horticulture Course- Nathan Jones</u> Moved: K. Mors Seconded: H. Darley 'Get Nathan Jones underway with Horiculture course'. Carried. (note: there is provision in the budget for staff development).
- 6. <u>Risk Management</u> from Toro conference in New Zealand a Compliance sub-committee would be a good idea. Andy Blacker, Jason Verhees and Deb Sykes to be on this.
- 7. <u>Creeping reduction in size of 1<sup>st</sup> and 2<sup>nd</sup> greens</u> will be redressed.

Andy was thanked for his attendance and input.

# GRANT POSSIBILITIES WITH JOANNA RALPH OF EP COMMUNITY CONSULTING

Joanna had e-mailed details including Background, Methodology, Services provided by EP Community Consulting, Terms of engagement and Fees for service prior to the meeting but because it was late in the day when e-mailed to Committee members they had not had a chance to peruse this.

A number of points were discussed including:-

- ·plan to have a dam capturing water which will reduce how much water is drawn from SA Water
- •this will be a community resource with water accessible by CFS once a standpipe and hard surface are in place (grant from Bendigo Bank approved for when this is in place).
- ·irrigation system also to be funded
- ·Joanna has had success in applying for grants through Grants SA who regard Social Inclusion (the aged, ethnic groups etc) favourably with points such as keeping fit, avoiding isolation useful. Letters of support from people such as Peter Treloar are also regarded favourably.
- •the Club cannot rely on membership fees alone to keep a viable Club so alternative sources of income such as RV Park are being investigated this could also increase employment
- ·meeting with ERDB suggested that Club could be a Community Hub for the area behind Winter Hill ·community use already includes bird-watching and Orienteering groups

·Community Development Programme employs people with disability and Remote Jobs Program assists work for the dole and New Start participants gain skills and future employment ·a possibility would be a grant to develop web page with links to Facebook, Instagram etc. Once a month (i.e. 12 times a year) \$5,000 grants come up through Grants SA

Joanna outlined the possibilities for her involvement and costs as outlined on what she had e-mailed. Joanna was thanked for her attendance.

There are other things such as solar panels which could be covered by grants.

Resolved that Committee members peruse information provided by Joanna and we come back to this at next meeting.
